Rules and Regulations:

Important - Please read these rules - they will be strictly adhered to.

1. The Show is held under the Rules of the Governing Council of the Cat Fancy, Copies of which can be obtained at a price of £2.00 including postage from Head Office. GCCF, 5 Kings Castle Business Park, The Drove, Bridgwater, Somerset, TA6 4AG.
2. Cats will be received at the entrance to the Show Hall on Saturday 3rd April 2010 from 8.00 am to 9.30am.
3. Every cat, including those for exhibition only, **MUST** be examined by the Veterinary Surgeon before being penned, Contravention of this rule will be followed by Disqualification and forfeiture of fees. All exhibits must have clean ears, be free from vermin and free from communicable disease. Veterinary Surgeons are instructed not to admit male cats which are either Monorchid or Cryptorchid. Any Exhibitor whose exhibit has been rejected or withdrawn on veterinary grounds from any GCCF Show should produce a Veterinary Surgeon's clearance certificate stating that the cat(s) in question had recovered by a specific date and/or there were no further outbreaks in the Cattery.
4. If an exhibit is unable to be shown owing to illness, 50% of entry fees will be returned providing that a Veterinary Surgeon's certificate is received by the Show Manager seven days prior to the date of the Show.
5. The Hall will be cleared of all but officials at 9.45am. Judging will commence at 10.00am promptly. The Show will open to the public from 12.30pm until 4.30pm.
6. All exhibits must be accompanied throughout their journey by the owner or the owner's bona fide representative and must be brought to the Show, in boxes, baskets or suitable containers. No exhibit will be accepted on a lead only. Exhibitors must provide their own food, sanitary trays and drinking bowls.
7. Entries unaccompanied by the proper amount of fees will not be accepted.
8. **REGISTRATION.** All exhibits (except those entered in Household Pet Classes), must be registered with the Governing Council of the Cat Fancy. All registered cats which have changed owners since registration **MUST** be transferred at least three weeks before the Show. Registration and Transfers should be sent to GCCF, 5 Kings Castle Business Park, The Drove, Bridgwater, Somerset, TA6 4AG.
9. No stud advertisement or written or printed matter of any kind other than the official award cards may be put on pens.
10. With the exception of cats entered in Exhibition Pens, no interior or exterior decoration or distinguishing objects will be allowed in or on the pens during the judging and judges will pass any pen so distinguished. Warm, white blankets, or Vet Bed, sanitary trays and dishes without markings must be provided. Exhibits with coloured or lined blankets or marked sanitary trays will be disqualified.
11. Exhibits are received on condition that the Club shall not be responsible for any loss or damage to cats, boxes, baskets or in any other way.

12 The Committee, on behalf of the Club, retain their exclusive right to publish catalogues of their shows containing information as to exhibits and names and addresses of exhibits and reserve to themselves the right to REFUSE ANY ENTRY WITHOUT GIVING A REASON.

13 The Committee reserves the power to cancel or amalgamate any classes not already guaranteed. Announcements of any alteration in the Schedule will be made on the GCCF website and will be deemed sufficient notice.

14. In the case of the Show being cancelled for any reason the Club reserves the right to retain a percentage of fees to defray expenses.

GENERAL GUIDELINES ON ENTERING SHOWS

Where possible always complete your show entry form from your GCCF registration document (ie Registration Transfer certificate) for the cat that is to be exhibited, PRINTING the details carefully to avoid any misinterpretation of your handwriting.

If you have not received your registration document at the time of entry, complete the show entry form with the details from the pedigree, giving the first choice of name if it is a non-prefix registration, and put RAF (Registration Applied For) or TAF (Transfer Applied For) or both, in the Registered No. box. It is wise to enclose a stamped self-addressed acknowledgement postcard with all registration and transfer applications, particularly for cats entered for shows, so that you know that the application has been received by the GCCF. Try and keep a copy of your entry form - then, when you receive registration details and number, check these against the entry form and notify the Show Manager in writing of any differences in the details as well as giving the registration number, if applicable. This may not be in time for the printing of the Show Catalogue, but the Show Manager should attach your letter to your entry form, which will save unnecessary notification of discrepancies when that show is checked. All catalogue errors are checked against the original entry form and any exhibitor's letters are used for reference. Show managements are permitted to accept corrections, at their own discretion, up to the close of the show on show day, such a change must not be a change or exhibit.

If you are entering several cats from your household and the registered owners (exhibitors) differ within that family/household, check with the Show Manager whether using one entry form is acceptable or not and, if it is, indicate VERY CLEARLY which exhibitor owns which cat, ensuring all owners sign the entry form. It may be less confusing and more acceptable to the Show Manager for each owner to use separate entry forms but joint owners of an exhibit/exhibits should always use the same form and BOTH MUST SIGN.

STATUS OF ERRORS - WHAT TO EXPECT

MINOR ERRORS. These warrant a notification for your reference if the error occurs more than once and it is apparent that registration details were available at the time of entry or before the date of the show. Continuous

repetition of the same error after notification will be referred to the Executive Committee.

Examples of minor errors include:

- (a) minor spelling errors
- (b) separation of names that should be one word, and vice versa.
- (c) overseas title preceding the name of an exhibit, sire or dam, etc
- (d) full breed number known but not given
- (e) Sire and Dam reversed (revised 5.1.94)
- (f) breeder joint when single and vice versa (revised 5.1.94)

INCORRECT DATE OF BIRTH. This is usually classed as a minor error unless it affects an entry into classes based on age groups when it could warrant disqualification of the exhibit from such classes but if the incorrect date of birth affects the age suitability as a whole, then the exhibit will be disqualified from the show.

N.B: AGE LIMITS: Kittens - not less than 14 calendar weeks and under 9 calendar months on date of show (with effect from 1.6.94.) Adults - not less than 9 calendar months on date of show.

INCORRECT NAME OF EXHIBIT/SIRE/DAM/OWNER/BREEDER. If registration / transfer details were available at the time of entry or before the date of the show, disqualification is inevitable. The following discrepancies are those which usually arise:

EXHIBIT/SIRE/DAM Omission of Administrative or Breeder's prefix; Incomplete name/unregistered name added; Sire and Dam reversed; Totally incorrect name or names.

REGISTERED OWNER: Joint when they should be single and vice versa (**EXHIBITOR**) Totally incorrect name or names; Declaration not signed by registered owners(s); NB The exhibitor(s) must be the registered owner(s) of the cat and not necessarily the person who actually takes the cat to the show

BREEDER: Totally incorrect name or names
NB The breeder of a cat is ALWAYS the registered owner of the dam on the date of the cat's birth.

REGISTERED/TRANSFER NOT RECEIVED BY GCCF 21 DAYS BEFORE THE DATE OF THE SHOW. These entries will be disqualified. Remember the effective date of all registrations and transfers is the **FIRST DATE OF VALID RECEIPT BY THE GCCF**, and if you enclose your own stamped addressed acknowledgment card with your application form this will be stamped with the GCCF office date of receipt.

TRANSFER OF EXHIBIT FROM EXHIBITOR TO A NEW OWNER RECEIVED BY GCCF MORE THAN 21 DAYS BEFORE THE DATE

OF THE SHOW. Entries such as these will also be disqualified as the exhibitor's entry form becomes invalid.

INCORRECT CLASS ENTRY. These will be disqualified from the class concerned, so always check with the Show Manager if in doubt about which class to enter. If a breed number is changed officially, it is important that you notify the Show Manager immediately.

CAT REGISTERED ON THE REFERENCE REGISTER No cat registered on this Register is eligible to be shown and therefore these entries will be disqualified.

The only exception to this is when a new breed becomes recognised; and then, cats of the breed may be shown even if they are registered on the Reference Register, as long as this was the only reason for the Reference registration.

Exhibitors can appeal against any disqualification resulting from show checking, giving their reasons. The appeal will be referred to the Executive Committee if considered valid and, if not, a letter of explanation will be sent to the exhibitor(s). The above advice, however, is aimed to keep your show entries trouble free, not to mention the show checking.

ADVICE TO EXHIBITORS AS FROM 1.6.92

- a) You are advised about against purchasing any shampoos that change a cat's colour as this can lead to disqualification.
- b) Homeopathic Vaccinations are not acceptable to the GCCF for the purpose of vetting-in.
- c) Any alteration to your entry must be in writing, which will be attached to the form by the show manager. You may also make corrections to the form up to the close of the show.
- d) Kittens under the age of fourteen weeks (14) may not be shown.
- e) Any person whose cats have been rejected under Sections C or D must not officiate as judge or steward or in any other capacity which requires the handling of cats at shows until a clearance certificate as required by the GCCF has been obtained.
- f) The use of small battery driven fans in pens can be dangerous, and could also be considered a distinguishing mark.
- g) Please note that in addition to the classes you have entered, your cat may also be handled for the purposes of assessing candidates in the GCCF appointment scheme
- h) Queens who have kitted within 12 weeks of the date of the show may not be shown.

VETERINARY CLEARANCE CERTIFICATES

EXHIBITORS: When cats have been rejected at Shows please note the following points:

1. When sending your clearance certificate to the Veterinary Officer, please include your copy of the rejection slip.
2. Please DO NOT send these certificates by recorded delivery as this can cause considerable delays in the receipt of your certificates. If you wish to

satisfy yourself that your letter has reached the Veterinary Officer please enclose a stamped, addressed postcard for acknowledgement of receipt, and this will be signed and returned to you.

3. Exhibitors should not attend Shows until they have received a letter from the GCCF confirming clearance. It is recommended that this letter be taken to Shows within a month of the issue of the clearance letter.

GENERAL NOTES FOR THE GUIDANCE OF EXHIBITORS

(a) If your exhibit is rejected by the duty veterinary surgeon before or during a Show, the GCCF will require you to produce a veterinary certificate of freedom from infection before being permitted to attend or exhibit at any future show. This certificate must be dated not less than seven days after the show at which the exhibit(s) was/were rejected and submitted to the GCCF with all relevant details.

(b) Evasion or breach of any of the GCCF rules, or of the articles of its constitution may, and often will lead to disciplinary action and you are advised to familiarise yourself with all sections of the Rules and with the Constitution. These are obtainable from the GCCF.

(c) Except where the context demands otherwise, the word 'Cat' in these rules includes kittens and neuters. A kitten is defined as a young cat under nine calendar months of age. Thus a kitten born on 12th January becomes a cat (adult) on the following 12th October

NEW RULE ON BITING AT SHOWS (Effective 1.6.88)

Any cat biting or inflicting injury by deliberately scratching a Judge, Veterinary Surgeon, Steward or other Show Official must be reported to the Show Manager. The Show Manager must withdraw the cat from the show and shall inform the owner of the cat in writing, sending a copy to the GCCF. If the cat was defending itself in exceptional and frightening circumstances, that information should be given to the GCCF for consideration by the Executive Committee. If the cat is reported at any subsequent show, it shall be disqualified from all future shows unless the Executive Committee rule otherwise.

RULE ON CONDITION (Effective 1.6.89) Section 4, Rule 4d

Any Cat or Kitten disqualified by a Veterinary Surgeon on grounds of condition must be reported by the Show Manager to the GCCF

DEFINITION OF CLASSES

OPEN CLASS Open to all of the specified breed .

CATS Not less than 9 calendar months on the day of the show

KITTEN Not less than 14 calendar weeks and under 9 calendar months on the day of the show (amended 20.10.93 effective 1.6.94)

NEUTERS Neutered cats, male or female, must be registered. Neuters may only enter neuter Classes and may not compete with entire cats or kittens except in Club Classes which are scheduled to include Neuters. Where Best in Show is held, the best Neuter shall be considered against the best Entire Adult and Kitten for Best Exhibit in Show. Neutered

kittens may enter any suitable class specified or Neuters other than Open Classes. (Amended 25.4.90 effective 1.6.91)

NOVICE Exhibits that have not won a First Prize in any class at a show held under GCCF Rules

LIMIT Exhibits that have not won more than four First Prizes in any class at a show held under GCCF Rules

DEBUTANTE Exhibits that have never been shown at a show held under GCCF Rules

MAIDEN Exhibits that have not won a First, Second or Third prize in any class at a show held under GCCF Rules.

BREEDERS Exhibits bred by exhibitors. Cats originally registered in the breeder's joint ownership but changed to single ownership through divorce or the death of one owner can still be entered in this class. Cats originally registered Breeder's single ownership and changed to joint ownership with the Breeder should be entered in the Non-Breeders Class

JUNIOR Cats over 9 calendar months of age and under 2 years on the day of the show

SENIOR Cats 2 years old and over on the day of the show

RADIUS For cats and kittens living under 50 miles from the show hall

VISITORS For cats and kittens living over 50 miles from the show hall

ARISTOCRAT Exhibits with 1 or 2 Certificates.

V.I.P. Exhibits who have 3 certificates from 3 different judges.

ADOLESCENT 9 - 15 months old on day of show.

The status of the exhibit for entering restricted classes (i.e. Maiden, Limit, etc) shall be cat's status on the day of entry, except where Section 2, Rule 15e applies. The wins as a Kitten do not count when the exhibit is shown as an Adult or Neuter; the wins as an Adult do not count when the exhibit is neutered and shown. Merit Awards do not count as 'wins' for entering restricted classes.

Go past the Roebuck Inn on the left; at the traffic lights turn left into School Road. FROM THE M40 (Warwick & Stratford on Avon)

Leave the M40 at J15 taking the A46 South (signposted Stratford on Avon). The A46 will bypass Stratford. Follow signs to Alcester. At the roundabout take the A435 (signposted Birmingham & Redditch). At the next roundabout, take the third exit (signposted Alcester). At the Globe Island, exit for Coughton and Studley. At the traffic lights turn right into School Road. At the T junction turn left into Kinwarton Road, go over Gunnings Bridge and take the next left into Gunnings Road and immediately left into the Greig Centre.

FROM WORCESTER

Take the A422, go through Inkberrow and follow the signs to Alcester. At the village of Arrow turn left at the T junction. At the roundabout take the exit for Alcester. At the Globe Island, exit for Coughton and Studley. At the traffic lights turn right into School Road. At the T junction turn left into Kinwarton Road, go over Gunnings Bridge and take the next left into Gunnings Road and immediately left into the Greig Centre.

FROM BRISTOL, THE SOUTHWEST AND EVESHAM

Leave the M5 at J9 and follow the signs for Evesham and Stratford. Continue on the A46 to Alcester. At the roundabout take the exit for Alcester. At the Globe Island, exit for Coughton and Studley. At the traffic lights turn right into School Road. At the T junction turn left into Kinwarton Road, go over Gunnings Bridge and take the next left into Gunnings Road and immediately left into the Greig Centre.
